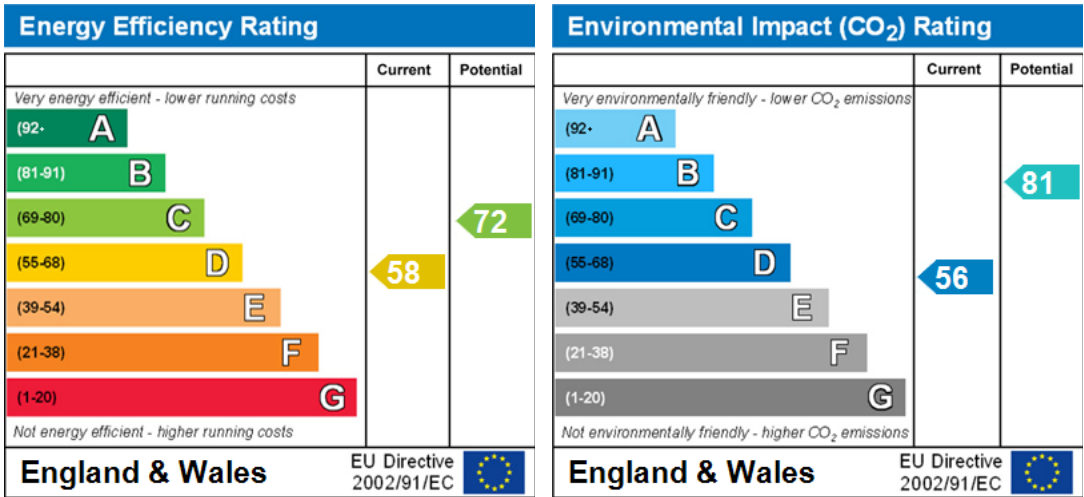

Relevant letting fees and tenant protection information
